### SUMMARY OF POLICIES & PROCEDURES

- Appropriate swim attire is required within the WaterPark; cut-offs and thong swim suits are not allowed. (NO JEWELRY ON SLIDES)
- Children 8 years and under must be directly supervised by someone at least 15 years of age at all times. Children ages 9-12 must have a signed **Parental Consent Form** on file.
- The WaterPark and Community Center is subject to closure(s) due to facility maintenance and inclement weather. Every effort will be made to post changes in advance.
- No food or beverage other than clear containers of bottled water (no jugs) may be brought into the Park. Picnicking is allowed outside the WaterPark.
- Purchased food and drink must be consumed away from pool and slide areas.
- A variety of food and beverages are available for purchase at our concession stands.

**WAIVER & RELEASE:** Read it carefully before you sign. In consideration of the acceptance of my application for entry into activity listed on this application, I hereby waive, release and discharge any claims for damages, for death, personal injury or property damage which I may have against the City of Antioch as a result of my participation. This release is intended to discharge the City, its agents, and employees from and against any and all liability arising out of or connected in any way with my participation in the activity, **even though that liability may arise out of carelessness or negligence on the part of the City or persons named above.** I further understand that accidents and injuries can arise out of my participation; knowing those risks, nevertheless, I hereby agree to assume those risks and to release and hold harmless all of the persons mentioned above who might otherwise be liable to me (or my heirs or assigns) for damages.
